

A. MUNICIPALITY OF MORONG, BATAAN SITUATIONAL REPORT:

Effective March 17, 2020, the entire Luzon area in the Philippines under was placed "enhanced community quarantine" (ECQ) which is effectively a total lockdown, restricting the movement of the population with exceptions, in response to the growing pandemic of coronavirus disease 2019 (COVID-19) in the country. This quarantine came two days after the implementation of the community quarantine of Metro Manila.

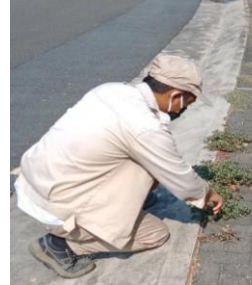
